Private Agricultural Sector Support Trust (PASS) (hereafter also referred to as "PASS" or "the Trust") is registered as a non-profit making and non-governmental organization in Tanzania, under the Trustees Incorporation Act, 2002 of the laws of Tanzania and was issued with a certificate of incorporation dated 28 May 2007.

PASS was established by the Government of the United Republic of Tanzania (through the Ministry of Finance) in collaboration with the Government of Denmark through the Royal Danish Embassy in Tanzania.

- 1. PASS has set aside funds for procurement of goods and service during the financial year 2025 to 2027. It is intended that part of the proceeds of the fund will be allocated to cover eligible payment under the contract for the supply of goods and provision of services.
